Important Notes:

1. An Activity Fee of \$75.00 for new students and \$50.00 for returning students is required to be paid at the time of registration. This Activity Fee is not refundable.

2. A Deposit of 50% of the last month's tuition is required to be paid at the time of registration. This Deposit will be credited to 50% of the tuition for your last summer month. This deposit is not required if the student is a continuing student currently enrolled at LCP. This deposit is non-refundable after May 1.

Important Dates:

Starting NOW: Registration for summer programs begins - sign up soon as space is limited!
Signed Registration Form, Activity Fee, and Deposit are due.

May 1, 2020: No withdrawals from summer registration are permitted past this date.
No refunds of deposits will be made after this date.

June 10, 2020: Tuition for July is due

July 10, 2020: Tuition for August is due.

TUITION PAYMENT PROCEDURES

***PLEASE NOTE:** Tuition is due on or before the 10th of the month prior to the one you are paying for. For example, July's tuition is due on June 20. A 5% late fee will be added to accounts not paid by the 20th. Students cannot be admitted to class if payment is not received by the first of the month. A \$15.00 charge will be added for any returned checks. Accounts that have checks returned twice will be required to make "cash only" payments. There is a \$5 per month service charge for payments made by credit card.*
